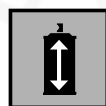

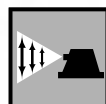
- Clean surface with a suitable degreaser then abrade

Shake aerosol for at least two minutes, after agitator ball is free



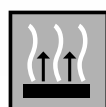
5 - 8 Minutes
